support.

 Resolution authorizing up to \$100,000 for a Phase 1 traffic study for Brackenridge Park area.

Reconciliation Plan

- The Brackenridge Park Master Plan was approved by City Council on March 2, 2017.
 - Restoration of natural park features
 - Restore, preserve, and articulate park cultural and historic features
 - Increase visibility and pedestrian access to / within the Park
- The City Council adopted the Midtown Regional Center Plan in June 2019 which includes several goals and strategies for the neighborhoods and commercial districts surrounding the Brackenridge Park
- The Brackenridge Park Conservancy released a Cultural Landscape Report in 2021 to build upon the recommendations of the Masterplan through the development of an interdisciplinary systems-based approach to the Park's preservation and future growth.
 - Heal Brackenridge Park's ecology
- Elevate its identity locally and nationally
- Protect and celebrate its many layers
- Usher it into the 21st century
- 10-Year Capital Needs Plan developed in 2022 by the City, Zoo, Witte, and Botanical Gardens to help identify the capital needs for Brackenridge Park, Witte, San Antonio Zoo, and San Antonio Botanical Gardens.

Reconciliation Plan Scope of Work

- Integrate and reconcile the planning documents into a Reconciled Project Inventory for Brackenridge Park with focus on the publicly accessible and City of San Antonio operated facilities within the Park.
- Implement a process with specific milestones to develop the Reconciled Project Inventory.
- Facilitate the process through a public process utilizing the input and guidance of the Brackenridge Park Advisory Committee.
- Facilitate the development or identification of an Equity Evaluation process for the implementation of capital projects.

Deliverables

- 1. Reconciled Project Inventory for Improvements to Brackenridge Park.
- 2. Deliver an Equity Evaluation Process to be used by the City of San Antonio and Midtown TIRZ board when considering the funding and implementation of future projects in the Park.
- 3. Maintain a shared project portal/file share accessible to the City of San Antonio and Brackenridge Park Conservancy to include all working documents, presentations, research in support of the project.

Management and Oversight

- 1. The effort will be staffed by the Office of Historic Preservation with support from the Brackenridge Park Conservancy.
- 2. Reestablish the Brackenridge Park Stakeholder Advisory Committee to provide feedback to the consultant, technical committee, and executive committee.
- 3. Create a Technical Committee that includes funders and project managers to ensure coordination of all the projects within Brackenridge Park.
- 4. Establish an Executive Committee.
